



OSTEOPATHY – WHAT TO EXPECT

Osteopathy is a form of manual therapy that can have beneficial effects for a variety of muscle and joint conditions. When you first visit an osteopath, you'll be asked about your current symptoms and medical history. All information will be treated as confidential in accordance with standards of practice set out by the General Osteopathic Council and the Data Protection Act 1998.

After an initial examination, your osteopath will discuss treatment options with you so that you can agree a course of action and the likely associated costs. Treatment may require several visits and, very occasionally, further tests and or referrals to other appropriate health care professionals.

Most osteopaths will begin your treatment at your first appointment – you may experience mild discomfort afterwards, but in most cases this will resolve within 24 hours. If you have any concerns about your treatment we encourage you to discuss these further with your osteopath.

You're more than welcome to bring someone with you for your consultation.

OSTEOPATHY, HELPING YOU MAINTAIN GOOD HEALTH IN LATER LIFE

Osteopaths spend four to five years training to understand the relationship between the body's organs, joints and muscles, and treat disorders of the musculoskeletal structures throughout the whole body.

As we get older our muscles, bones, ligaments and joints will also age. Ageing alone does not necessarily result in increased pain or stiffness. Some people with age-related pain find that treatment and advice from an osteopath complements GP care and pharmaceutical products. Osteopathic treatment and advice may help you feel better prepared to continue with, or adapt, your lifestyle as your body changes with time.

HOW CAN YOUR OSTEOPATH HELP?

Osteopathic treatment is a hands-on approach offering a package of care that is personalised to you. If you begin to notice problems as you get older, your osteopath can work with you to keep you healthier, allowing you to enjoy the pleasures of life despite the natural aging process.

Arthritis is more common in older people. Although no one can cure arthritis, you may find that together you and your osteopath can discuss ways for keeping active, preventing common problems such as falls, and managing osteoporosis.

WHAT YOU CAN DO TO MAINTAIN YOUR HEALTH AS YOU GET OLDER:

30 minutes of daily exercise (enough to make you warmer and breathe harder, whilst still able to have a conversation) can help reduce the risks associated with circulation problems and falls. It can also improve mood. This might include activities such as dancing or brisk walking.

Make sure you also eat a healthy, varied diet.

The use of trainers or similar footwear can help absorb shocks and take the pressure off your knees, hips and spine when walking for longer periods.

A short rest can help recover energy for the remainder of the day's activities.

Although aches and pains may be a common element to ageing, they don't have to get in the way of your lifestyle.

WHO RECOGNISES OSTEOPATHY?

The UK National Institute for Health and Care Excellence recommends spinal manipulation for lower back pain. Osteopaths are trained to deliver such treatment and offer self-management advice.

The General Osteopathic Council regulates the practice of osteopathy in the UK, promoting patient safety by setting and monitoring standards of osteopathic conduct. By law, an osteopath must be registered and comply with strict regulatory requirements. This gives patients the same sort of guarantees and protection as those given by doctors and dentists.
